ABCS Statement of Faith

We believe the Holy Scriptures of the Old and New Testament to be the verbally and plenary inspired Word of God. The Authorized King James Version of the Bible shall be used in all member churches and in the activities of the ABCS.

We believe there is one triune God, eternally existent in the persons of the Father, the Son (Jesus Christ), and the Holy Spirit.

We believe in the virgin birth of Christ, His sinless life, His miracles, His vicarious and atoning death through His shed blood, His bodily resurrection, and His ascension into Heaven.

We believe that the Holy Spirit's work is to convict, regenerate, indwell, sanctify, and illuminate all who are born into God's family through Jesus Christ. We are opposed to the charismatic movement and its tongues and other sign manifestations.

We believe God created the heavens and earth in six literal days and that man was created in the image of God but chose to sin, therefore all persons inherit a deprayed nature and are lost sinners in need of salvation.

We believe that the only legitimate marriage is the joining of on man and one woman. We believe that homosexuality, lesbianism, bisexuality, incest, fornication, adultery, and pornography are sinful perversions of God's gift of sex. We believe that God disapproves of and forbids any attempt to alter one's gender by surgery of appearance.

We believe Christ's blood, shed on Calvary, is the only atonement for man's sin. We believe that salvation is a free gift by grace through faith for "whosoever will." We believe that all men who accept Christ as their personal Savior are eternally secure. We do not believe that God pre-elects men to heaven or hell.

We believe that since the resurrection of Christ, God has ordained the church to carry out His work in the world. We believe in the following Baptist distinctives: biblical authority, autonomy of the local church, priesthood of all believers, the offices

of pastor and deacons, individual soul liberty, saved and baptized church members, the ordinances of baptism and the Lord's supper, separation of church and state, and separation of the believer from the world.

We believe that Satan rebelled against God and was cast out of heaven with a host of angels who followed him. He introduced sin to Adam and Eve in the Garden of Eden. He continues to turn people from the truth and against God. Eternal hell was created for Satan, his demons, and people who do not believe in Jesus Christ.

We believe in the resurrection of both the saved and the lost: the saved to eternal life in heaven and the lost to eternal damnation in a literal lake of fire.

We believe in the imminent, pre-tribulation return of Jesus Christ for all believers. The rapture of the saints will be followed by a seven year tribulation after which Christ will return in glory to judge the world and set up His millennial reign on earth.
